# Types of Personal Information We Collect

We collect data that identifies you directly or indirectly. This may include but is not limited to:

- Contact details: your name, surname, email address, and telephone number.
- Correspondence: Any additional information you provide through emails, letters, or calls.
- Transaction details: Information relating to transactions for fulfilling your instructions.
- Your employment status, tax jurisdiction, financial status, and property information.

# Data Source and Usage

Your personal information is either provided directly by you or obtained indirectly from third parties. We use your information to:

- Offer, extend, or modify services to you.
- Understand your needs and preferences.
- Improve the quality of our services.
- Resolve any queries, complaints or requests.
- Verify the accuracy of the personal information provided.
- Share with third parties for business purposes or credit risk analysis, if necessary.



# **Third-Party Sharing**

We may share your personal data with our trusted partners, service providers, and other third parties that perform services on our behalf. All our third-party service providers are required to take appropriate security measures to protect your personal data in line with our policies. We do not allow them to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

# **Marketing**

We may use your personal information to market our services to you via telephone, or electronic communication. You can request us to stop sending marketing communications at any time.

# **Storing Your Personal Information**

We retain your personal information for as long as required by law or necessary for our services. These records may be held in electronic format.

### Your Consent

If you've given your consent for us to process your personal data, you can withdraw it at any time. This does not affect the processing that's already occurred.

### Objecting to the Processing

You have the right to object to the processing of your personal information under certain circumstances. If we agree with your objection, your personal information will only be processed as provided for in the law.

## **Security of Personal Information**

We have implemented measures to ensure the security of your personal information. Only employees and service providers who need access to your information to perform their duties are granted access and only if they comply with our security measures.
